- **2. Entering In-Person Orders:** Families can start entering their paper order card totals. The section for in-person nut and candy orders is available for families until Sunday, October 15th. - **3. Product Permission Forms**: Don't forget the last day for Product Permission forms is next Wednesday, October 11th. Here is the link to the form in case you need to send it to families: 2023-2024 Product Program Permission Form.

If there is a Girl Scout's name you do not recognize, please let us know so we can make sure they are in the right troop.

If you appear to be missing Girl Scouts, please check your email as we have been reaching out to families and troop chairs of Girl Scouts who have been placed in our holding tank due to permission form or membership issues.

6. Bark Box Update from GSUSA: The Fall Program's 2023 BarkBox online shipped pilot is outperforming expectations and is forecasted to exceed its initial production quantities. BARK has been an excellent partner and has made significant accommodations to conduct a secondary production run so councils and Girl Scouts may continue optimizing on these sales. These products will be available to ship to consumers in February 2024. Current existing inventory is available to fill current orders and the backorder is expected to be in effect by the middle of the week. There will be a change in messaging on the M2 site. Consumers will have ample notice prior to purchasing that the product will ship in February and self-determine if they would like to proceed with their purchase.
