Hello Troop MagNut Chairs,

Thank you for taking on the role of Troop MagNut Chair for your troop. We appreciate your help providing the Fall Product Program to your Girl Scouts. This is your MagNut News for the Week – your e-newsletter for updates, reminders, and information during the 2024 Fall Product Program. You will receive these emails on Tuesdays. Here's the top 4 pieces of information you need for the week.

1. Don't forget to complete your Troop Chair Training in the gsLearn system using your MYGS login. Thank you to those who completed the training. If you have not finished the training, please remember that the training needs to be done by Sunday, September 15th to ensure you have access to M2OS when it opens up to volunteers on Friday, September 20th. If you cannot complete the training by that time, your troop will still be able to participate in the Fall Product Program but access to the M2OS will be delayed a day or two. If you are having difficulty accessing the training, please email customercare@nmgirlscouts.org and we will have a staff member reach out to make sure you are set-up correctly.

2. Check your email if you have completed training. We have begun to email troop chairs with specific information for your area, get you connected with your Service Unit Chair and provide information on how to pick-up materials for your troop. The subject line for the email is "2024 Fall Product Program Training Complete - Important Follow-Up Info." Please make sure to read this email so you have all the information you need to get your troop ready for the program. Emails are sent within 2 business days after completing training.

3. Product Permission Forms and Google Sheet. Don't forget to have Girl Scout families complete their 2024-2025 Product Program Permission and Financial Responsibility Form found here: <https://forms.gle/zRUZQ69D7iCKycxF7>. This form needs to be completed each year for each Girl Scouts. We have started to update the Google Sheet for each Service Unit. Please note that we have the date in the top row so you know where we are in processing forms.

4. Troop Q&A Sessions. Don't forget you have the option to attend virtual Troop Q&A sessions to get your questions answered. These sessions are not required but available when you need it. See the attachment for dates, times and Zoom login information.
